Proposed 2023-2024 Budget

- ★ This budget once again falls under the New York State Tax Cap!
- ★ Additional state aid this year eliminates the need to buy 2 new school buses and a facilities vehicle using district capital reserve funds.
- ★ Capital Project continues as planned, with parking lot repaving, new bleachers at SHS, and HVAC work.
- ★ Contrary to a statewide trend, Spackenkill continued to **gain K-12 student enrollment** in 2022-2023, at a preliminary rate of 2.9%
 (Source: NYSED Public Access Data Site and NYSED Information and Reporting Services Public School Enrollment).
- ★ Spackenkill's **Non-Resident Student Tuition Program** has grown from 1 student in 2017 to 33 students as of 2022-2023, providing additional revenue of approximately **\$425,700** to the district.
- ★ During the 2022-2023 school year, the District piloted a Universal Pre-K program at Mid-Hudson Early Education Center for 32 students and has added a class of 16 to serve more students in 2023-2024.
- ★ Summer Academy 2022, a 3-week program for elementary students, provided reading, writing, and math support as well as socialemotional learning. Summer Academy 2023 is being planned.



Dear Spackenkill Residents:

On Tuesday, May 16 at Spackenkill High School from 7 am to 9 pm, District voters have the opportunity to vote on a \$51,918,432 budget for the 2023-24 school year and to elect one trustee to the Board of Education. The vote also includes a proposition for the creation of a Capital Reserve Fund, in the ultimate amount not to exceed \$10,000,000 over a term of ten (10) years. The intent of the Capital Reserve Fund is to appropriate funds necessary to finance, in whole or in part, the cost of capital expenditures. The goal is to reduce, and in some cases eliminate, the need to borrow funds. The Capital Reserve Fund is a proactive measure to maximize the value and use of taxpayer dollars by saving on the interest and legal fees associated with borrowing.

The proposed budget represents a 2.99% increase over the 2022-23 budget. The proposed tax levy is \$328,381 under the allowable State tax cap and is an increase of 1.66% from last year—matching the lowest increase in the past five years and in keeping with the District's goal of moderating fluctuations in the tax levy from year to year.

The BOE and administration are cognizant of the economic issues associated with high rates of inflation over the past two years. The District is not exempt from those same issues. With that in mind, the administration has developed a budget that supports the District's educational mission while keeping the tax levy as low as possible. The BOE has carefully reviewed the proposed budget throughout its preparation and is in support of it. We encourage you to give the proposed 2023-24 budget your careful consideration and we ask that you vote on May 16.

Project ADAM Recognizes Spackenkill

Spackenkill Union Free School District is **the first district in New York State to receive recognition from Project ADAM** (Automated Defibrillators in Adam's Memory) for the District's cardiac arrest preparedness.



Dana Colasante and Alice Schoen, coordinators for Project ADAM New York, and Dr. Christa Miliaresis, Pediatric Cardiologist and Medical Director of Project ADAM New York, visited all four Spackenkill Schools in March and presented administrators and nurses with banners that celebrate Spackenkill's efforts, which include Heartsaver CPR/AED certification courses for all staff at least three times a year, with coaches taking a First Aid and CPR/AED course every two years.

On a biannual basis, Spackenkill's 11th and 12th grade students take the CPR/AED certification course provided by our high school physical education staff. In addition, the Athletics Director and SRO conduct annual Emergency Response Team drills in each building and the Athletics Director and Athletics Trainer do medical emergency drills with teams.

Working with Dr. Riter

On our March Superintendent's

Conference Day, Dr. Riter built on her previous work on ACEs (Adverse Childhood Experiences), talked with teachers and staff about executive function and the student brain's limbic system as well as the different types of stress, while also touching on such topics as resilience and the ability to retain focus. Above all, she encouraged teachers and staff to continue "being courageous and stepping forward" when it comes to making school a better place for students.

WHAT IS

TAX LEVY VS. TAX RATE?

A school district's tax levy is the amount the district plans to collect from all of its taxpayers in a given year. The tax rate is the number that is used to determine your property tax bill.

The **tax rate** is calculated by dividing the tax levy by the total of assessed property values provided by the Town of Poughkeepsie Assessor's Office. Because tax rates are generally expressed as "per \$1,000 of taxable assessed value," the product is divided by 1,000.

2023-24 BUDGET, CAPITAL RESERVE PROPOSITION, & TRUSTEE VOTE

RESOLVED, that the Board of Education of the Spackenkill Union Free School District be and it is hereby authorized to appropriate the necessary funds to meet estimated expenditures of the district in the sum of \$51,918,432 for the 2023-2024 fiscal year; such funds to be raised by a tax on the taxable property of the district to be levied and collected as provided by law.

Shall the Board of Education of the Spackenkill Union Free School District be authorized to establish a capital reserve fund for the purpose of appropriating sufficient funds necessary to finance, in whole or in part, the cost of capital expenditures, including but not limited to the construction and reconstruction of additions, renovations, refurbishments, replacements and/or repairs to its facilities, including original furnishings, equipment, machinery, apparatus, appurtenances and incidental improvements and expenses in connection therewith, as identified from time-to-time and recommended in its capital facilities plan, in the ultimate amount not to exceed \$10,000,000 over a probable term of ten (10) years; and that such amount shall be raised from the unexpended and unencumbered funds previously levied upon the taxable property located in the Spackenkill Union Free School District?
